LOCKE LORD BISSELL & LIDDELL RECEIVES HIGHEST RANKINGS IN *GLOBAL BROKER & UNDERWRITER* MAGAZINE'S 2008 LEGAL SURVEY

(CHICAGO) August 25, 2008 – Locke Lord Bissell & Liddell was ranked as the No. 1 law firm in the United States in six separate categories by *Global Broker & Underwriter* magazine in its just-released 2008 legal survey.
