Locke Lord Attorneys to Judge Chicago Debate League Varsity Season Opener Tournament on Saturday, Oct. 1

September 28, 2011 – An estimated 65 varsity debate students from 16 Chicago public high schools will put their skills to the test and get a dose of life in a large law firm setting Saturday, October 1, during the Chicago Debate League’s “A” Conference Varsity Season Opener at Locke Lord’s Chicago Office, 111 South Wacker Drive.

The daylong tournament will include a panel discussion on the connections between urban debate and the legal profession. The high school competitors will showcase their debate skills before 20 volunteer judges, all attorneys with the Chicago Office of Locke Lord LLP who went through special training to judge this event. The tournament is an opportunity for urban public school students to debate in a corporate setting and to connect with professionals willing to mentor them on debate and presentation skills as well as career choices.

Participating in the Chicago Debate League has been shown to improve public school students’ academic achievement and college readiness. A study of the first 10 years of the Chicago Debate League found that debaters improved their grades, had a much higher graduation rate and were better prepared for college than non-debaters based on ACT standards. CDL debaters spend on average 410 hours outside of the classroom researching, writing and debating the national high school debate topic.

The “A” Conference Varsity tournament is one of four Chicago Debate League events set for Oct. 1 at venues around the city. Altogether, more than 500 students from Chicago public high schools are expected to compete.
