May 2016: Memorial Day

Historically known as "Decoration Day," Memorial Day honors those who have served in the military. "Decoration Day" was originally established by General John A. Logan in order to commemorate Civil War soldiers. On May 30, 1868, 5,000 people gathered at Arlington National Cemetery in Virginia in celebration of the first Decoration Day. Attendees that day adorned the graves of over 20,000 fallen Civil War soldiers. Following World War I, these celebrations were extended to commemorate soldiers who had served in all wars throughout our country's history. In 1968, the Uniform Monday Holiday Act passed, moving Memorial Day to the last Monday in May and establishing it as a federal holiday.

## Locke Lord Veterans

**Andy Anderson** (Boston) served in the U.S. Navy from 1965-1969, and was an officer on Atlantic Fleet destroyers nearly the entire time. His main ship, the USS Robert L. Wilson, was based in Norfolk, VA, but it spent much time at sea. During the Cold War, he had a post-overhaul visit to Guantanamo Bay and two extended attachments to the Sixth Fleet in the Mediterranean. **Chris Bakes** (Sacramento) served in the U.S. Navy and was commissioned as an officer in December 1980, reporting for duty following law school and passing the bar in 1981. He attended Officer Indoctrination School and Naval Justice School and served as a trial attorney and defense counsel for service members. He later served as a Staff Judge Advocate in Italy on USS Orion, AS-18.
